Fête Des Fleurs Vendor Application

Dear Vendor;

Thank you for your interest in the Chateau St. Croix Fête des Fleurs. This is the 6th annual Fête Des Fleurs, the flowering of the vines, celebration. Last year, we had approximately, 6,000 people for our festival. We continually strive to make our Arts and Crafts show the premier show of the region.

GENERAL INFORMATION:

The event is held at the Chateau St. Croix winery. The arts and crafts show is held behind the winery in a level grassy field. The event is held June 19-20, 2010. Setup can begin Friday, June 18 at 12:00 noon.

Event hours are Saturday 11:00 a.m. to 7 p.m. and Sunday 11:00 a.m. to 5 p.m., all booths must be open during this time. All exhibitors must be ready to open by 10:00 a.m. Saturday morning or their space will not be held. Please be prepared for inclement weather as the festival continues rain or shine.

We greatly encourage vendors to demonstrate their art or craft.

FEES:

The booth space fees are as follows:

- \$50.00 for a 10' x 10' booth
- \$75.00 for a 10' x 20' booth
- \$100.00 for a 10' x 10' booth with electricity
- \$125.00 for a 10' x 20' booth with electricity

PARTICIPATION:

This is a juried arts/crafts show and the application deadline is May 10, 2010. Applications received after this date will be placed on our waiting list. All applicants will be juried. Only juried items may be sold. The jury will make its final decision on all completed applications by May 10, 2010. We will contact all participating vendors at that time. All booth space fees are due with your application. Your application will not be considered if the booth fee does not accompany the application. Credit cards will not be processed for applicants that are not accepted. There are no booth fee refunds for vendors that are accepted and then decline or withdraw.

A committee will evaluate all applications based on the photos or samples of the work submitted. Please include 3-6 photographs of your art or craft. A photograph of your booth is desired but is not a requirement.

Please write a very brief description explaining the process, technique and materials used in creating your product. Please keep in mind that the jurors can be different from year to year so attention to presentation is of utmost importance. No crafter will be allowed in the show without advance acceptance and confirmation. If your booth requires a corner set-up or certain size or locations needs, be sure to indicate that on your application. Once booth spaces are assigned it is difficult to change them.

RESPONSIBILITY:

Exhibitors must firmly cover their display in case of wind or rain. By acceptance of this agreement, the exhibitor expressly releases Chateau St. Croix Winery and its representatives from all liabilities for any damages, injury or loss to any person or goods in any sense.

PARKING:

Parking is included in the booth fee. Crafters planning to park or camp overnight are welcome to do so. There is a designated primitive camping area and primitive toilets. Crafters camping overnight do so under their own supervision.

RULES:

- All items displayed and sold must be handcrafted by the exhibitor and be of first quality – only juried items may be sold.
- All trash must be placed in the nearest trash container.
- No alcoholic beverages are allowed to be sold.
- Exhibitors must be open at all times during the show.

NO APPLICATION WILL BE CONSIDERED UNLESS COMPLETE.

Please use this as a checklist.

1. Application form.
2. Photos/sample of the art/craft to be sold at the festival. Photos/CDs will be returned if a stamped, self-addressed envelope is enclosed. Photos are accepted. Digital photos are accepted on a CD. NO SLIDES are accepted.
3. Photo of your booth display labeled with your company name. This is desired but not required.
4. Booth fee for desired booth space. (Credit cards will not be processed and checks will be returned to you if you are not accepted. Checks will be cashed May 10, 2010.
